**Approve minutes from prior meetings:** D Kalmerton made a motion to approve minutes from planning commission meeting, 02/19/24. Seconded by Al Meyer. Motion carried.

**Public Hearing:** on a request from Adam Rademacher, on Parcel #0811-281-8400-2, 5 acres, currently zoned A-1(EX) (Exclusive Agriculture), located at 5239 Town Hall Dr. Adam would like to break off 1+ acre(s) for a family member to build a new home. After a brief discussion, a motion was made to break off 1.113 acres to build a new home. Motion by: D Yelk

**Public Hearing:** On a request from Dan & Tammy Grady, on Parcel #0811-353-8850-0, 61.13 acres, currently zoned A-1(EX) (Exclusive Agriculture), located at 4777 Pierceville Rd. Dan & Tammy would like to break off 1+ acre(s) for his daughter and son-in law to build a new home. After a brief discussion, a motion was to create a 1.072 acre lot on the corner of Pierceville Rd. & Baxter Rd. There will be a shared driveway with the existing residence on Baxter Rd. A conservation easement is required. Dan still needs to submit a rezone application. Motion by: D Yelk Seconded by: P Stang Motion carried.

**Preliminary Hearing:** on a request from Marjorie Kriel, on Parcel #0811-094-9360-6, 2.50 acres, currently zoned A-1(EX) (Exclusive Agriculture) and Parcel #0811-094-9340-0, 4.02 acres, currently zoned A-1(EX) (Exclusive Agriculture), located at 2440 Bailey Rd. Marjorie is thinking of dividing her property to make 3 more lots for new homes, she would keep her old home. Chairman, D Yelk told Marjorie she would have to rebuild her driveway (Lens Rd.) to a Town Road following all of the Town Road specs at her expense. After a brief discussion, Chairman D Yelk suggested that Marjorie also go to the City of Sun Prairie Plan Commission and ask what their plans are, for future expansion around her property.
