**Call to Order:** Chairman L Updike called the board meeting to order at 4:03 p.m. at the Town Hall, 5556 Twin Lane Road. Consider and Take Action: Approve the rezone from Adam Rademacher for Parcel #0811-281-8400-2, 5 acres, located at 5239 Town Hall Dr., currently zoned A-1(EX) (Exclusive Agriculture) to SFR (Single Family Residence). Parrott, representative from General Engineering Company (GEC) about contracting with them to perform Building Inspector duties for the Town of Sun Prairie. Supervisor D Yelk motioned to go ahead and start the transition of changing services from SAFEbuilt to General Engineering Company (GEC). Supervisor J Seltzner seconded. **Consider and Take Action:** Discussion of Proposed Agreement between Town of Sun Prairie and General Engineering Company (GEC) for Building Inspection Services. This was discussed. No action was taken.

Consider and Take Action: Discussion of Proposed Delegated Municipal Authority between Town of Sun Prairie and General Engineering Company (GEC). This is provided by the state once our new building ordinance has passed and the contract with General Engineering Company (GEC) is completed. There was no action taken.

**Consider and Take Action**: Discussion of Termination Date with SAFEbuilt for Building Inspection Services. Supervisor D Yelk motioned to terminate the contract with SAFEbuilt effective 7-1-24 if possible, if they require the 90 days, make effective date 90 days from June 1, 2024 for all new building permits. This effective date will also depend on the Town adopting the updated building code ordinance.

**Consider and Take Action**: Discuss and Amend 2024 Budget. Budget was discussed, but no action was taken. Need final numbers before we can amend the budget.

Consider and Take Action: Discuss and Approve Pellitteri's 10-Year Contract Extension Proposal for Residential Waste & Recycling Collection Services in the township. Board requested we contact Wisconsin Towns Association (WTA) to see if we are required to put this out for bid. No action was taken.

**Road Report:** Patrolman J Schuster reported that the crack filling has been completed. Seal Coating will begin this week. Mowing will start this Friday or next Monday.

Chairman L Updike brought up that the parents of a local Boy Scouts troop are nervous about the kids being on Bailey Road performing trash pickup. They are asking for either a park or section of a road that is less busy. Heather, the Boy Scouts POC will coordinate with our Patrolman J Schuster to determine a safer place for them to perform trash pickup.
